The office of the Idaho State Public Defender (SPD) is now accepting applications for law student interns and externs for Spring 2027. The number of available placements and in which offices may fluctuate as budget allows.

The State Public Defender (SPD) is a client-centered agency which provides holistic representation that meets the highest ethical and professional standards to protect the rights of people who cannot afford to retain counsel. The agency supports a fair and just legal system that values the humanity and dignity of all and requires integrity in all lawyer-client relationships. All public defense in Idaho is funded by the State of Idaho and managed by the State Public Defender. Our employees work with the highest levels of diligence, respect, and compassion for our clients and strive to innovate and find solutions in every case we handle.

With close supervision and guidance from experienced attorneys, interns/externs will be involved in the following activities:

- Reviewing trial court records and evaluating legal claims;
- Drafting briefs;
- Conducting legal research and drafting memoranda; and
- Participating in attorney issue conferences and moot arguments.

In addition, interns/externs may be involved in:

- Communicating with clients in-person, over the phone, and/or in writing;
- Drafting motions; and
- Observing/appearing for hearings and/or depositions.

The SPD will consider applications from current 3Ls in their final semester of law school who are eligible for a Limited License from the Idaho State Bar. Interns/externs must have excellent research and writing skills and be creative, critical thinkers. Interns/externs must be comfortable working with clients from diverse backgrounds. Successful candidates will have strong academic credentials and an interest in indigent defense. Applicants will be required to apply for and receive a Limited License from the Idaho State Bar. Interns/externs will receive a stipend of \$6,400 for 8 weeks of full-time work (320 hours total). Additionally, interns/externs who agree to be placed in one of our rural offices will receive a living expense stipend of \$4,000 to assist with rental and other relocation expenses. Rural office eligibility will be determined by the SPD.
